Squannacook Greenways has been busy in 2018 working on fundraising and the permitting process to allow the construction of the Squannacook River Rail Trail. We have finished our permitting processes with the state of Massachusetts and with the town of Groton, both important milestones. At the end of 2018 we hired the engineering firm Ducharme and Dillis to help us prepare to file a Notice of Intent with the Townsend Conservation Commission, the final step in the permitting process. We expect to file that in early 2019, in preparation for construction beginning in November 2019.
