Squannacook River Rail Trail Townsend and Groton, Massachusetts

RAIL TRAIL CONSTRUCTION - Section 4

Crosswinds Drive to Fisherman's Parking Lot

The Squannacook River Rail Trail will be a 3.7-mile aggregate hard-pack trail along an abandoned rightof-way owned by the Massachusetts Bay Transportation Authority (MBTA). The entire length of trail will begin at Depot Road in the center of Townsend, MA and end at the Bertozzi Wildlife Management Area in Groton, MA, running along the former Peterborough and Shirley rail corridor.

Squannacook Greenways is building the rail trail over four construction years, completing approximately one-quarter of the trail each year. The first phase of construction, from Depot Street to Old Meetinghouse Road in Townsend, was completed in 2020-2021. The second phase, from Old Meetinghouse Road to Harbor Pond in Townsend, was completed in 2021–2022. The third phase, from the north crossing of Crosswinds Drive to the Bertozzi Wildlife Management Area (WMA) in Groton, was completed in 2022–2023.

Squannacook Greenways, Inc. invites interested parties to submit a bid for construction of the fourth phase of the rail trail. This section will be approximately 0.9 miles long, from the north crossing of Crosswinds Drive in Groton to Route 119 in Townsend Harbor at the informal dirt parking area known as the fisherman's parking lot.

Approximately 0.7 miles of the phase 4 project is in Townsend and 0.2 miles in Groton. Squannacook Greenways is requesting separate price quotes for the Townsend and Groton sections.

Work required under this contract includes furnishing all materials, equipment, and labor for construction. Railroad ties will be removed, sub-base prepared, and a graded surface of 3/8-inch minus compacted aggregate will be installed. The aggregate surface will be 10 feet wide. Most of the 80-foot right-of-way will remain undisturbed.

Tasks include developing a staging area, removing stumps and vegetative debris from the rail corridor, removing organic soil material from the trail surface and storing on site for reuse, removing ties and delivering them to a permitted disposal facility, restoring drainage and stabilizing the corridor as needed, grading the existing sub base, installing aggregate hard pack surface, building up and grading soil material along the sides of the trail, and seeding the trail edges. Several locations have erosion damage that require repairs to the riverbank, rail corridor, and culverts.

All work shall be done within the period of November 7 to March 15, to fulfill permitting requirements for the Natural Heritage & Endangered Species Program (NHESP).

About Squannacook Greenways, Inc.

Squannacook Greenways, Inc. is a non-profit 501(c)(3) corporation organized in 2011 to build and maintain the rail trail. In 2015, we secured a 99-year lease of the rail corridor from the MBTA to build a recreational trail. This trail is being constructed using private funding and is not covered under prevailing wage rules.

Regulatory Requirements

This rail trail project is regulated under the Massachusetts Endangered Species Act. All construction shall take place between the dates of November 7 and March 15 to avoid impacts to sensitive habitat.

The project shall also adhere to Best Management Practices (BMPs) developed by the Massachusetts Department of Environmental Protection (DEP) to manage construction risks associated with development of former railroad rights-of-way into rail trails. No soil shall be removed from the rail corridor and excavation shall be kept to a minimum to prevent exposure to potentially contaminated soil.

Minimum Requirements for Contractors

Bidder must presently have, or will procure at time of contract award, personnel, materials, and equipment necessary to perform the services outlined in this Invitation to Bid. Bidder must hold all pertinent licenses in the Commonwealth of Massachusetts.

The bid must include evidence of a minimum liability coverage for personal injury, bodily injury, and property damage with limits not less than one million (\$1,000,000.00) dollars per occurrence and three million (\$3,000,000.00) dollars in aggregate. Umbrella liability coverage with limits of not less than two million (\$2,000,000.00) dollars covering all work performed must also be provided. Such insurance shall be written on an occurrence basis (as opposed to a claims-made basis) and name Squannacook Greenways, Inc. and the MBTA as additional insureds. This requirement is specified by the MBTA lease.

The bidder acknowledges that the permitting and other documents associated with the work, as listed in the Specifications, are part of the work specifications, and that its bid includes all costs to comply with the permitting and other requirements outlined in those documents.

The bidder acknowledges that it has had free access to inspect the trail, staging areas, and other work areas; that it has a full understanding of the requirements and challenges associated with construction; that its bid includes all costs to complete the listed work tasks; and that change orders shall not be submitted due to unanticipated conditions on the trail and associated work areas.

Squannacook Greenways, Inc. reserves the right to accept or refuse any or all bids at our sole discretion.
